Proportion of infected/infested samples tested positive compared to results from the standard test, see appendix 2 of PM 7/98	97.5%
Standard test(s)	Calculation was done on the basis of expected results which for some samples differ from the health status of the samples. Expected results for isolate TSWV-PV-1175 which was tested in the 5 serial dilutions were determined based on the results of preliminary studies: for last two dilutions of 1,000,000x and 100,000x expected result was negative. Additionally, in the TPS study, 100x diluted TSWV-PV-0182 isolate and 10,000x diluted TSWV-PV-0389 isolate have been used as medium and as low concentrated TSWV positive sample, respectively.
